The Board will consider this possibility at an upcoming Board meeting.)

The Board bids farewell to Ryan Bosch, Carole Karbonik and, as mentioned above, Vicky Qualie, all of whom recently completed two-year terms, as well as to Denise Auriat, who was appointed to the Board last year to fill a vacant position. We thank all of these individuals for their service and leadership as Board members and look forward to their continued involvement with our school.

Working Together

The success of our school depends on continuous effort, among board members, school council members, administrators, teachers, parents, students, and government officials, to co-operate, collaborate, and communicate effectively. As a public charter school, we are required to have a volunteer Board of Directors which acts as the governance body of the school. It sets direction, formulates policy, and makes decisions as required in the School Act, the New Horizons School Charter, and the bylaws of the New Horizons Charter School Society.

Implementation of the Board's policies and directions are the responsibility of the superintendent and principal. The school's administrators, teachers, and support staff are responsible for the educational programs in the school and, in partnership with each student and his or her parents, the educational needs of each child.

The **New Horizons School Council** promotes the wellbeing and effectiveness of the entire school community in order to enhance student learning. Parents have the opportunity through the School Council to advise the principal and the Board on any matter relating to the school.

Parents have the responsibility and right to advocate on all matters of their own child's education. Discussions of parental concerns begin with the classroom teacher. In situations where matters cannot be resolved at the classroom level, parents are invited to raise their concern with the principal and subsequently, if there is still no resolution, with the superintendent. Where a decision of an employee of the Board significantly affects the education of a student, the parents of the student may appeal the decision to the Board. The Board will only hear an appeal after the concern has been dealt with according to the established process at the classroom and administrative levels

The Work of the Board

Major responsibilities of the Board of Directors include:

- Meeting Alberta Education requirements: Education Plan, Annual Education Results Report, and the school's budget.
- Initiating, monitoring, and reviewing the Board's policies.
- Considering educational matters initiated and recommended to the Board by the administration.
- Engaging parents and staff in meaningful consultations regarding priorities and direction for the school.
- Negotiating a collective agreement with the Alberta Teachers' Association.

Relevant documents and information are generally prepared by the superintendent, secretary-treasurer, principal or the Board's legal counsel and brought to the Board for information, discussion, revision, and approval. The Board will also solicit input from the School Council, Society members, parents, students, and members of the school staff as necessary to keep informed and fulfill its reporting requirements.

The Board of Directors is directly accountable to the New Horizons Charter School Society and, through the *School Act* and the *School Charter*, to the Minister of Education.

Board Meetings

Regular meetings of the Board of Directors are held monthly and are open to the public. Unless otherwise noted, meetings begin at 7:00 p.m. and are held in the Learning Commons at the school. Specific Board meeting dates for the entire year can be found on the school website. The agenda and supporting documents for each meeting will be posted on the school website about five days before each Board meeting; parents are notified by email when the documents have been posted.
